Clinton Path Preschool is founded on the belief that having parents involved with the running of the school helps to establish community and, therefore, naturally eases the transition for our children as they make their way in their new school environment. Parental participation in school shows your child you value this experience. In addition to these benefits, being involved in the CPP community is a lot of fun!

Parental involvement in the school is significant but not overwhelming. As co-op members, parents perform diverse administrative and maintenance tasks, participate in planning and policy-making for the school, and have access to a community of families and teachers. The school welcomes parental visits at any time, and encourages parents to join their children at lunch, providing a relaxed opportunity for discussion with other parents or teachers.

Parental participation is essential at Clinton Path Preschool. The following is a list of parental responsibilities during the school year:

1. Attend all Parent Meetings (four per year, generally held on Monday evenings).
2. Participate in the two Parent Work Days (usually held on Saturdays, once in the fall and once in the spring).
3. Clean the school on a rotating basis (approximately two times each year).
4. Fulfill a cooperative job (one per family).
